REVIEW OF PARKING ORDINANCE

The Commission began their review of the current Hunts Point Municipal Code parking ordinance. There have been various concerns expressed by residents regarding parking issues. The Mayor indicated he heard from a resident about the landscaping trucks that are present every day and the noise that it creates. She requested that the Town consider asking residents to have landscaping done only on designated days. The Commission did not believe that was feasible.

The Commission decided they wanted more input from residents about concerns regarding parking in the Town. Staff will send out a message to all residents asking them to provide any comments regarding parking and any suggestions for changes. Also the Medina police department will be asked to provide input on enforcement issues or problems that they encounter. The Commission will continue their discussion on this issue at their next meeting.

MISCELLANEOUS

The Commission will look at landscaping issues including the traffic circle at a future meeting. The Mayor reported on proposed milfoil spraying for this year. He indicated that the company that does the spraying believes that milfoil is under control and they want to consider spraying for other invasive plant species especially various pond weeds. Commissioners reported that milfoil was still present in many areas and that milfoil spraying should continue.

MOTION: Recommend to the Town Council that the milfoil spraying done in past years be continued for 2015. Moved by Olson, seconded by Frantz.
