



## When to Call 9-1-1

The Medina Police Department encourages citizens to **always** report suspicious activity. 9-1-1 operators are well-trained to quickly assess any situation and take appropriate action. Calling 9-1-1 versus the Medina Police Department general line will enable police to respond and take necessary action faster.



Suspicious activity or behavior is anything that strikes you as wrong, abnormal, or unusual. Examples of suspicious activities by individual(s) include:

- Staying in the same place for a long time, in or out of a vehicle.
- Sitting in a vehicle observing an area closely.
- Avoiding eye contact.
- Looking around furtively, especially at night, without apparent cause.
- Carrying unusual objects that seem out of place with surroundings.
- Fleeing when noticed.

**If you see something you think looks suspicious, call 9-1-1.**

When calling, be as descriptive as possible to describe the situation. Remember, suspicious behavior or activity does not always indicate ill intent or crime, but your observations can make a difference by helping to deter, prevent, or respond to crime.

#### **Shredder Day**

“Shredder Day” is a terrific opportunity to protect yourself from identity theft and is sponsored by the Medina Police Department’s Crime Prevention Program. **PROSHRED Security** will be at the Medina Park off NE 12<sup>th</sup> Street so you can witness your documents being shredded on site.

#### **Drug “Take-Back” Program**

In response to rising rates of prescription drug abuse and the dire need for safe drug disposal, the Medina Police Department will once again be on site collecting unused or expired prescription drugs. Proper disposal of unused drugs saves lives and protects the environment. ***Please remove all pills from the bottles/containers ahead of time and bring the pills in a Ziploc baggie.*** This allows the ability to throw the empty bottles away at your own home and any identifying information on the prescription label will be kept private. Pills that are in “blister packs” such as cold medicines do not need to be individually pushed out of the packs. Liquids such as cough medication are ok to bring if the lids are securely tightened. ***No sharps of any kind will be accepted, including injectables, syringes, diabetic needles or EpiPen’s. Medical waste will also not be accepted.***

#### **3R TECHNOLOGY: e-waste recycling and re-marketing services**

3R technology will be available on site to collect electronics, working or non-working, you wish to dispose of. This is an ideal way to get rid of electronics.

Items that will be accepted include:

- TV’s & Monitors – LCD and Plasma
- Computers & Laptops
- Servers & Networking Equipment

- Printers, fax machines, copiers and scanners
- DVD players/VHS/Stereos
- UPS battery backups
- Telecom equipment & cell phones
- Ink & toner cartridges
- DVDs and CDs
- Keyboards and Mice
- Microwaves
